Sub: The amendment of clause 42(ii) & 42(iii) of the C.P.W.D. standard contract form No. 7 & 8.

CORRECTION SLIP CLAUSE 42(ii) AND 42(iii).

Sir,

In supersession of this Ministry's letter of even number, dated the 24th July, 1984, I am directed to convey the sanction of the President to the amendment of paras (ii) and (iii) f the clause No. 42 of the C.P.W.D. standard contract form No. 7 & 8 as under:-

"CLAUSE 42(ii):- After completion of the work, the theoritical, quantity of cement to be used in work shall be calculated on the basis of

statement showing quantity of cement to be used in different items of work provided in Delhi Schedule of Rate, 1977 printed by the CPWD. In case any item is executed for which the standard constants for the consumption of cement To not available in the above mentioned statement or cannot be derived from this statements, the same shall be calculated on the basis of standard formula to be laid down by the Superintending Engineer of the Circle concerned. Over this theoritical quantity of cement, shall be allowed variation up to 3% plus/minus for works estimated cost of which as tender is not more than Rs. 5 lakhs and upto and plus no estimated cost of which put to tender is more than Rs. 5 lakhs. The difference In the quantity of cement actually issued to the contractor and the theoritical quantity including authorised variation, if not returned by the contractor, shall be recovered at twice the issue rate, return of materials governing the contract. In the event of its being discovered Hat the quantity of cement used is less than the quantity ascertained as herein rein before provided (allowing variation on the minus side as stipulated ove), the cost of quantity of cement not so used, shall be recovered To the contractor on the basis of stipulated issue rate and cartage to

Mutatis-Mutendis in the resisted reinforcement or structural steel sections (each diemetre/section or category shall be considered separately) when that the theoritical quantity of the steel shall be taken as the quantity required as per design or as authorised by Engineer-in-Charge Including authorised lappages plus 3% wastage due to cutting into pieces. Over this theoritical quantity 2% plus/minus shall be allowed as variation due to wastage being more or less."

DG(W), CPWD will, however, review the actual wastage/variation of cement/steel being used in different items of works by conducting detailed field study and comparing effects of proposed amendments.
