- The work shall be executed as per CPWD specification.
- 2. No T&P shall be issued by the department.
- 3. The rates should be quoted in both figures and works including all taxes and cartage etc.
- 4. The undersigned reserves the right to reject all or even lowest tender without assigning any reason.
- 5. DDA is not responsible for any litigation with labour in Court of Law & contractor will settle the matter on his own risk & cost.
- 6. DDA will not pay any compensation to the labour of any mishappening occurred during the execution of work.
- 7. If any material is rejected or work found defective, the same shall be removed/rectified by the contractor within one will, failing which the same shall be removed/rectified by the department & cost will be recovered from the agency as approved the Competent Authority.
- 8. The quantity can be increased or decreased as per actual requirement at site.
- 9. The instructions of the department staff have to be carried over properly. In case of any difference of opinion/interpretation of specification and condition, the matter shall be referred by the contractor to the officer-in-charge for his decision which shall be final and binding.
- 10. The contractor must be available at site of work whenever officer-in-charge visits the site.
- 11. The contractor shall take all necessary precautions to avoid accident. He shall be responsible for all damages and accidents caused due to negligence on his part during the executions of work. No such claim in his account will be entertained by DDA.
- 12. The departmental instruction issued from time to time will be also be applicable.
- The contractor/tenderer must be enlisted as Horticulture Category Contractor in DDA and CPWD.
- 14. The measurement of all the items should be done through E-measurement.
- 15. The PH value of water should get tested from authorized laboratory in Contractor's cost.
- 16. The water supplied must be free from any kind of pathogens and waste and suitable for irrigation of plants.
- 17. The work has to be completed within stipulated period.
- 18. Water tankers can be used for filling of over head tank, and nothing extra shall be paid on this account.
