- The decision to award the work to L1 bidder i.e. M/s Ernst & Young LLP was already taken during the 7<sup>th</sup> WAB (2024) meeting held on 15.10.2024. Further, it was informed that the amendments in MPD 2021 for ISR (In-Situ Rehabilitation) is still pending for notification and is likely to be notified by the Ministry of Housing and Urban Affairs soon and the agency shall have to undertake the activities as per the revised policy under approval.
- In continuation to above directions in 6<sup>th</sup> and 7<sup>th</sup> WAB (2024) meeting, it is further decided in the 8<sup>th</sup> WAB (2024) meeting that, the agency shall have to take up the above mentioned 3 in-situ projects (at Sl. no. 1, 6 and 7) on priority and the balance in-situ projects shall be conveyed to be taken up in due course of time.
- The Agency shall undertake the activities as per the revised policy/norms in MPD 2021 for ISR (In-Situ Rehabilitation).

#### <u>Decision:</u>

After due discussion and deliberation, Board agreed with the recommendation of CE (Rohini Zone) and accepted the lowest bid of M/s E&Y LLP at their quoted amount of Rs 5,34,48,531.85 /- which is 84.61% below the estimated cost not put to tender i.e. Rs 34,73,00,000.00/-. The board further directed that the agency shall undertake the activities for the preparation of revised RFP and DPR for 3 Priority in-situ Projects as per the revised ISR policy/norms under approval.
