1. The work of the Consultant Doctor will involve providing OPD service at the clinics at Vikas Sadan and Vikas Minar on part time basis in either of the following shifts:-

	<b>From 2:00 PM to 6:00 PM</b>
2. The applicant will indicate the shift for which he/she will offer his/her service. However, services of the Consultant Doctors can be utilized at any location or in any shift by DDA.
3. The Consultant Doctor would be entitled to the payment of Rs.50000/- per month for 4 hours shift in a day and 5 days in a week (*proportionate deductions will be made in case of absence*).

4. Emergency medicines will be made available by DDA while any other medicines as per prescription will be required to be purchased by the patient as per his/her OPD treatment.
5. The engagement is temporary and purely on contractual basis initially for a period of 06 months which may be extended further depending upon the requirement and satisfactory performance of Consultant. This will confer no right on the Consultant for permanent employment.
6. Candidates are requested to bring duly filled in Application form (in prescribed format), 02 passport size photographs and all original documents along with one set of self-attested photocopies of the documents in support of the educational qualification and experience, if any, on the date of interview.
7. The candidates are advised to report for walk-in-interview on 16.03.22 latest by 10.30 A.M. at **Conference Hall, Ground Floor, Vikas Sadan, New Delhi- 110023**, failing which their names will not be registered to appear for interview under any circumstances.
