WHEREAS, disciplinary proceeding under Regulation 25 of DDA Conduct Disciplinary & Appeal Regulation, 1999 were initiated against Sh. Dwarka Prasad S/o Late Sh. Gopi Chand, Peon (Regular) vide Memo No. F3(182)2006/PB-IV/1368 dated 07.11.2019 for willful/un-authorized absence from duty.



AND, WHEREAS, Sh. Sudhir Kakkar, Superintendent Engineer Civil (Retd.), DDA was appointed as Inquiry Officer to enquire into the charges framed against Sh. Dwarka Prasad S/o Late Sh. Gopi Chander, Peon (Regular) vide memorandum No. F3(182)2006/PB-IV/1329 dated 04.10.2021.

AND, WHEREAS, the Inquiry officer vide case S.K./I.O./INQ.REPT/2021/DDA/45 dated 22.12.2021 has submitted inquiry report wherein the charges framed against Sh. Dwarka Prasad S/o Late Sh. Gopi Chand, Peon (Regular) have been "PROVED". Further, vide notice no. F.3(182)06/PB-IV/23 dated 06.01.2022, a copy of the Inquiry report was sent to the said official and also given an opportunity to make any representation, if any against the findings of the Inquiry Report. The Copy of the Inquiry Report has also been pasted at the address of Sh. Dwarka Prasad S/o Late Sh. Gopi Chand, Peon (Regular). Sh. Dwarka Prasad S/o Late Sh. Gopi Chand, Peon (regular) has failed to submit representation against the proceedings of the Inquiry Report within stipulated period.

AND, WHEREAS, after careful consideration of the facts on record and the Inquiry report, I am of the considered view that the said Sh. Dwarka Prasad S/o Late Sh. Gopi Chand, Peon (Regular) has shown absolute lack of devotion not only by willfully absenting himself from duty but also not replying to the notices sent to him from time to time. A number of opportunities have also been given to him explain his conduct, but he has failed to do so. It is clearly evident that the employee has shown lack of devotion of duty, lack of absolute integrity and has acted in a manner unbecoming of an employee of the Authority and has proven beyond doubt that he is not a willing worker. The undersigned is also of the view that ends of justice would be met if the Major Penalty of "Removal from service which shall not be a disqualification for further employment" is enforced upon Sh. Dwarka Prasad S/o Late Sh. Gopi Chand, Peon (Regular).

Now, therefore, the undersigned, being the disciplinary authority under Regulation 3(d) of DDA (Conduct, Disciplinary And Appeal) Regulation, 1999 impose the penalty of **"Removal from service which shall not be a disqualification for further employment"** with immediate effect on the said Sh.
