If not granted, their pay will be fixed under the provisions of FR22(I)(a)(1). They may exercise their option for fixation of pay under the provision of FR22(I)(a)(1) within 30 days from the date of issue of this order.
- 3. If the above named officials have not qualified the Departmental Examination in Accounts as per terms & conditions of his appointment/under the provisions of various circulars issued from time to time on the subject, he will not be entitled to draw any increment in the scale of pay of Assistant Engineer (Civil) till such time he qualifies the said examination.
