ORDER

WHEREAS, Shri Deepak Kumar Gaur S/o Late Shri Khem Chand, was appointed in DDA as Peon on Compassionate ground.

AND WHEREAS, Shri Deepak Kumar Gaur S/o Late Shri Khem Chand, Peon was absenting himself since 12.03.2013 as intimated by the Deputy Director (NL)-II vide letter dated 01.04.2013. Memorandum was issued on 07.06.2013, 29.05.2014, 16.07.2014 and 16.09.2014. The Memo was also issued by the Personnel Branch vide letter dated 15.05.2013 and its reminder dated 22.10.2014. But no reply has been received from Shri Deepak Kumar Gaur S/o Late Shri Khem Chand, Peon.

AND WHEREAS, it was decided to take action under Regulation 30(A) C of the DDA Conduct and Disciplinary Regulation, 1999 which provides that "Notwithstanding anything contained to the contrary in any other regulation the service of any employee may be terminated by the Authority if; he remains on unauthorized absence for sixty days of more".

AND WHEREAS, a notice under Regulation 30(A) C of the DDA Conduct and Disciplinary Regulation, 1999 was issued followed by the Public Notice in the Newspapers on 15.07.2022 but no reply or representation has been received. By this Act, Shri Deepak Kumar Gaur S/o Late Shri Khem Chand, Peon exhibited absolute lapse of devotion of duty, lack of absolute integrity and in a manner unbecoming of an employee of the Authority.

NOW, THEREFORE, in exercise of the power conferred by 3(d) of the DDA Conduct, Disciplinary and Appeal Regulation 1999, the undersigned being the Disciplinary Authority hereby terminates the services of the said Shri Deepak Kumar Gaur S/o Late Shri Khem Chand, Peon under Regulation 30(A) C of the DDA Conduct, Disciplinary & Appeal Regulation, 1999.
