A total of 6714 properties were sealed so far. 2186applications have been received for de-sealing properties. During the fortnight no de-sealing cases have been approved by Monitoring Committee.

**6. Regular Monitored Case**: Removal of encroachment on govt. land by the owners of ground floor on the areas meant for Tot lots / parking / open space: Regarding the encroachment in pkt.1 Mayur Vihar Phase-I, as per the status report provided by EDMC dated 07.10.2020, all the brickworks and MS fencing have been completed in 54 tot lots. In the balance work of two tot lots, the work could not be started due to a Govt. ESI Dispensary running on it. In this regard, a notice has been issued to the medical officer for clearing the tot lots area but till date they have not cleared. The matter is being pursued in the concerned department and work will be completed in all respect within two weeks.

To resolve the complaint in time and prior to transfer, a consent has to be made regarding the jurisdiction finalised either by telephonic conversation or by joint inspection with the officer concerned grid."
- b. ATR to be uploaded on the Web Portal in Old Cases: Status on the 7376complaints in which detail ATR is not available to be uploaded by ULBs & Govt. Agencies. SDMC has to upload ATR on 5712 old cases, 963 for North DMC, 3 for EDMC, 685 for DDA and remaining pertains to other ULBs/Govt. Agencies. The situation has not been improved in-spite of repeated directions from Chairman STF, ULBs have not taken action.
