**Modification in the Layout plan of Pockets A-I, A-II, A-III, B-I, B-II, B-III, D-1, D-2 and D-3 of Sector 29, Rohini, Phase IV and V regarding proposed locations of 11 K.V. Electric Sub Station.
(File No. DIR(Plg)R/2006/Service/S-29/2012)**

Synopsis

Executive Engineer (Electrical) E.D. 9/DDA has requested for 11 K.V. Electric Sub-station (45Nos.) in plotted pockets A-I, A-II, A-III, B-I, B-II, B-III, D-1, D-2 and D-3 of Sector 29, Rohini Phase IV and V for electrification of these pockets. The proposed location of 11 K.V. Electric Sub-stations (45 Nos.) are marked on the Layout Plan of plotted pockets and placed before the Screening Committee for consideration.

1.0 BACKGROUND

Executive Engineer (Electrical) E.D. 9 has requested for earmarking 11 K.V. Electric Sub-Stations (45 Nos.) in plotted pockets A-I, A-II, A-III, B-I, B-II, B-III, D-1, D-2 and D-3 of Sector 29, Rohini Phase IV and V. Based on further interaction with Electrical Wing and representatives of TPDDL (Tata Power Delhi Distributory Limited) on 12.09.2012 the current proposal has been worked out.

2.0 EXAMINATION

The proposal of TPDDL for 11 K.V. (45 Nos.) ESS (Electric Sub-station) with size of 8 m. x 10 m. in Pockets A-I, A-II, A-III, B-I, B-II and B-III of Sector 29 was forwarded vide letter No. F-3(80)EE/ED-9/DDA/1284 dated 06.08.2012 by Ex. Engg. (ED-9) DDA and further for 11 K.V. (13 Nos.) ESS with size of 8 m. x 10 m. in Pockets D-1, D-2 and D-3 of Sector 29 was forwarded vide Letter No. F3(80)EE(E)/ED-9/DDA/1514 Dated 06.09.2012. The proposal was examined and a meeting called in the Chamber of Dir. (Plg.) Rohini on 12.09.2012, which was attended by officers of TPDDL and EE(E) ED-9, DDA for confirmation of sites/ locations/ feasibility and availability of sites which was accepted by the Technical Team/ officers of TPDDL and EE(E) ED-9.

As per MPD-2021 one (1) number 11 KV ESS is required to be provided for 10000 population. However, the current requirement by the Power Company is based on proposed FAR of the residential scheme. Accordingly, the 11KV ESS proposed in respective Layout Plans are on higher side than prescribed in MPD-2021. Earlier the Screening Committee, DDA has approved ESS on these lines.

It is also observed that 6 No. sites of ESS (measuring 4m. x 4m.) has already been approved and handed over to then NDPL (presently TPDDL), besides 3.No. of ESS (measuring 8m. x 10m.) are part of approved Layout Plan. Now 45 No. of ESS sites have been proposed including sites already part of approved Layout Plan in Green Area i.e. Parks/ Tot-Lots etc. and in Parking. The ESS is permitted in all use zones. The location of 11 KV ESS proposed by TPDDL and forwarded by EX. Engg. (Electrical) ED-9 to Planning Wing are marked on the copy of Layout Plans of respective Residential Pockets.

There is no change in area in respective Layout Plans.


5.0 FINANCIAL LIABILITY / SOCIAL GAIN


There is a social gain in providing sites for ESS as the proposal will help in electrification of Plotted Pockets in Sector 29, Rohini, Phase IV.


6.0 FOLLOW-UP ACTION

2. Land Disposal Wing / DDA - For Allotment based on demarcation by Engineering Wing (Civil)/Rohini and to take possession of ESS deleted in Layout Plans as per Para 2 above.
3. Engineering Wing (Civil) / Rohini - For demarcation and development
4. Director (Landscape) - For information and necessary action.
