Title of Agenda: Modification in the Layout Plan of Sector - 32, 36 & 37 and utilization of vacant land in Sector - 33, Rohini, Phase - IV & V regarding proposed location of Physical Infrastructure i.e. Sewage Pumping Station, Command Tank, 220 KV & 66KV Electric Sub-Stations.

Synopsis

Engineering Department (Civil and Electrical), DDA requested for Physical Infrastructure i.e. Sewage Pumping Station, Command Tank and 220 KV & 66KV Electric Sub-Station sites. The proposed locations of these sites in the Layout Plan of Sector - 32, 36 & 37 and utilization of vacant land in Sector - 33, Rohini, Phase – IV & V is placed before consideration of Screening Committee, DDA.

1.0 BACKGROUND:

The locations of SPS – 3 in Sector – 37, Rohini, Command Tank – II and one Electric Sub-Station of 220KV in Sector – 36, Rohini and Six (6) Electric Sub-Station of 66KV in Sector 32, 33, 36 & 37 were finalized in the meeting under the Chairmanship of Chief Engineer (Rohini) on 8th January 2013 in which representatives of Planning, Landscape, Land Management and Engineering (Civil & Electrical) were present. The current proposal is based on the same.

2.0 EXAMINATION:

(i) Layout Plan of Sector- 32, Rohini, Phase-IV was approved in the 224th Screening Committee meeting held on dated 24-06-2003 vide item No. 46:2003 and Layout Plan of Sector- 36 & 37, Rohini, Phase-V was approved in the 258th Screening Committee meeting held on dated 16-07-07 vide item No. 104:2007. Layout plan of Sector – 33, Rohini is yet to be approved and the proposal is only for the utilization of vacant land in Sector – 33, Rohini.

(iii) Command Tank - II and Sewage Pumping Station - 3 (SPS-3):

a) These locations were finalized as per requirement and feasibility by the Engineering Wing in the Meeting taken

by Chief Engineer (Rohini) on 08/01/2013.

b) As per the feasibility marked on the Layout plan of Sector 36 & 37, Phase V, Rohini based on the feasibility received from EE, RPD-8 on 22.08.2007 in File No. Dir (Plg.)R/5036-37/2006, the small area of the Green adjacent to the proposed site for SPS-3 in Sector 37 along the proposed 30.0 M R/W Road is presently inaccessible as the entire area is surrounded by encroachment. This green will be made accessible only after the construction of the 30.0 M R/W Road.

(iv) Electric Sub-Stations of 66KV (6 No.), 220KV (1 No.):

 a) All above locations were agreed by SE(E) Circle-2 and representative of TPDDL in the meeting taken by Chief Engineer, Rohini on 08.01.2013. It was informed by SE(E) Circle-2 that in addition to two 66 KV ESS provision
