Scheme 1981. The Hon'ble L.G. has now taken a policy decision and approved the proposal for carving out of approx. 16,000 plots for clearing the backlog of pending Registrants of Rohini Resdl. Scheme 1981. The said pocket is a part of approved Zonal Development Plan of Zone-M and the land use of the said pocket is Residential. The community facilities are already indicated as part of approved Sector plan and the tentative feasibility report was received from the Ex Engineer/RPD-2 vide letter No. F50(37)/05-06/RPD-2/513 dt. 29.4.06 and subsequent station survey report vide letter No. F1(21)AE(P)/RPD-4/DDA/772 dt. 7.7.09 and has been considered


