

## CIRCULAR

Sub: Medical Awareness

Ref: F & E Circular No. 19/2015, dated- 27.07.2015.

Further to above, rates & conditions of CGHS are reproduced for strict compliance. Recently, one of the Zonal office recommended reimbursement of Rs. 1.99 lacs fo hip implants.

## Reimbursement of Cost of Knee and Hip Implants

(i) The cost of knee and hip implants shall be reimbursed as under:

Τ,	Maximum Ceiling
Item	0-mont Rs 5 000/-
Knee Implant	Rs.60,000 + the cost of Bone Cement Rs.5,000/-
Hip Implant	Rs.35,000 + the cost of Bone Cement Rs.5,000/-

(ii) The beneficiary should have undergone the treatment in a Govt./Private recognised hospital with prior permission of competent authority.

(iii) The implant shall be purchased on the recommendation of the orthopaedic specialist of the recognised hospital and based on the lowest of three quotations.

(iv) The treating orthopaedic specialist shall issue a certificated to the effect that the implant has been implanted successfully and is functioning satisfactorily.

(v) Medical Advance for the purchase of implant shall be paid directly to the supplier, which will be up to 80% if the lowest quotation or 80% of the maximum reimbursable amount, whichever is less.

Vide No. F&E Circular No. 19/2015, dated- 27.07.2015, following instructions were circulated.

"For all knee replacement cases, detailed medical history from the initial date of trouble/freatment will be required to be enclosed with the estimate. For knee replacement cases also, opinion of at least two specialists (orthopaedic) of leading hospitals will be required to be attached preferably one from panel hospital and another from Govt. Hospital. For strict compliance by all Zonal offices and also Medical Cell-I and Medical Cell-II (HQ)."
