### Opening of limited number of Individual (Permanent) memberships for Siri Fort Sports Complex

1. Delhi Development Authority offers limited number of Individual (Permanent) Memberships for Siri Fort Sports Complex, August Kranti Marg, New Delhi-110049.
2. 800 Individual (Permanent) Memberships are being offered in the following categories:-
  - i) 250 nos. in Govt. category. (Employee of Central Government, State Government of GNCTD and Local Bodies of GNCTD and those individuals whose pay and allowances are being drawn from the Consolidated Fund of India/State).
  - ii) 250 nos. in Non-Govt. category.
  - iii) 150 nos. for existing Tenure Members of Siri Fort Sports Complex.
  - iv) 150 nos. for existing Associate Members of Siri Fort Sports Complex.

- Applications for memberships are to be submitted online at <https://online.dda.org.in/golfcourse> along with non-refundable application fee of Rs. 2500/-, including GST. Incomplete applications would be summarily rejected. Physical submission of application form would not be entertained. The registrations will start on **12th August, 2025 at 12:00 AM** and the last date of submission of applications is **11th September, 2025 at 11:59 PM**. After scrutiny of applications, entry fees for those whose memberships are approved would need to be paid online within 30 days from the date of offer of memberships. If, entry fees is not received within this period, the offer of memberships would be withdrawn and offered to other applicants who are in the waiting list.
- Dependants (spouse and children from 5 to 21 years) can be added in the membership of individuals. Dependants would need to pay monthly subscription and would be entitled to use the available facilities in the complex.
- If there are more number of applicants in any of the categories mentioned at para 2 above, the memberships would be granted in the following names: -
  - Govt. and Non Govt. category–By draw of computerized lots.
  - Associate Members–Based on the seniority of obtaining the membership. The oldest member in terms of date of membership in chronological order will be placed first in the list.
  - Tenure Members–Based on the number of times that Tenure Memberships has been obtained.
- Only one application is to be submitted by an applicant. If an applicant submits more than one application, then her/his applications would be rejected.
- Membership, if granted, can be terminated if it is established later that documents submitted by the applicant on the basis of which membership has been granted are incorrect, false or forged.

- Tenure memberships granted through discretionary powers will not be considered for these reserved vacancies.*
