





During the meeting while confirmation of the minutes of the 1<sup>st</sup> Technical Committee meeting dated 22.01.2015 with respect to Item No. 7/2015 related to requirements of stack parking, as per the information given in brochure of the service provider to NBCC (refer pages 41/C to 44/C) as provided by the representatives of NBCC, it was decided that the minimum height for stack parking be modified by replacing 3.6mt by 3.2mt in view of the options of minimum height available for stack parking.
