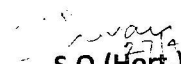

Ten Thousand Only) as earnest money in the form of Pay Order/Demand Draft in favour of **"CAU (Sports), DDA"** to be submitted Account branch in Chilla Sports Complex, which will be refundable after the auction is completed except for the highest bidder who will have to deposit 25% (Pay Order/Demand Draft) of the offered amount after adjusting Earnest Money of Rs. 10,000/- as precaution money. Balance amount of 75% (including on 100% of the total offered amount) shall be deposited through Bank Pay Order/Demand Draft in favour of **"CAU (Sports), DDA"** within 30 days from the date of issue of demand/acceptance Letter or any extension thereof. In case the amount is not deposited within the stipulated period the entire precaution money (25% of the offered amount) deposited by the bidder shall be forfeited absolutely and no claim on this account will be raised by in any forum or court. The bidder shall be informed accordingly.
