GUIDELINES FOR POST BIDDING PROCESS OF E-AUCTION FOR ALL PROPERTIES

I. 14th phase onwards LOI, Demand letter, Possession letter etc. will be issued through BHOOMI portal of DDA only. The URL of BHOOMI portal is <https://eservices.dda.org.in/user>. Therefore all the prospective bidders are requested to read the below mentioned instructions carefully before participating in e-Auction.

II. After registration on e-auction portal (www.ddaeauction.co.in) any registered user/intending bidder will fall in any one of the below three categories :-

III. For user/successful bidder falling under category II(a) type, only a system generated mail will be sent to their registered email ID containing LOI details and successful bidder can access/login the BHOOMI Portal through existing user ID and Password for accepting LOI and making 2nd Stage EMD.

IV. For user/ successful bidder falling under category II(b) type, successful bidder is directed to change/update the mobile number / email ID in the BHOOMI Portal itself before participating in e-Auction as post bidding related communication from DDA (LOI, Demand Letter and Possession Letter etc.) and will be issued to existing user on the email ID registered in BHOOMI Portal only. Any request for re-issuance of LOI, Demand Letter and Possession Letter etc. will not be considered under any circumstances.

V. For user/ successful bidder falling under category II(c) type, two emails will be sent to his/her registered email ID. One will be containing the user ID and temporary password to access/login BHOOMI Portal and the second one will be containing LOI details. Bidder can access/login the BHOOMI Portal through user ID and temporary password and after first login, they can reset the password and proceed for accepting LOI and making 2nd stage EMD. It may be noted that for users falling under category II (a) and II(b) type, only one email will be sent to their registered email ID available on BHOOMI/AWAAS portal containing LOI details. All the system generated email post e-Auction will be send to the bidder's registered email ID through email ID ddaeauction@dda.org.in. This is a system generated email, so please do not reply to this email.

VI. Successful Bidders of any type of properties will be able to download the LOI under the LOI tab after login to the BHOOMI portal after their bid has been accepted by the Competent Authority. Similarly, successful bidder (LOI holder) who has deposited 2nd stage EMD within stipulated time will be able to download the Demand Letter under Demand Letter tab and successful bidder who has deposited balance premium (75% of H1 bid) within stipulated time will be able to upload the requisite document under Possession Letter tab and download the Possession Letter under Possession Letter tab.

VII. All the payment shall be accepted only through the payment link provided in the BHOOMI Portal against each demand.

VIII. Demand letter and Possession letter will also be issued to eligible bidders through BHOOMI Portal only and a notification email will be sent to the registered email to the on BHOOMI /AWAAS portal of DDA in a similar manner as mentioned in para 05 above.

- X. The process of issuance of LOI, Demand Letter and Possession Letter which is mentioned in the respective tender document of different types of properties has been modified to that extent, so bidder may kindly note the same before participating in e-Auction.
- XI. The other terms and conditions of respective tender documents of different types of properties including payment terms and conditions and their stipulated timeline will remain same.

CHAIRMAN STF REVIEWS PROGRESS AT 76TH AND 77TH STF MEETING

The 76th meeting of STF was held on 03.12.2021 wherein officers from all the local bodies and other concerned agencies were present. The progress of the complaints received up to 30th November 2021 was reviewed.

In total 111247 complaints have been received in STF till 30th November 2021 and action on 104803 complaints has been initiated. 3671 ATR were received during the period from 01.11.2021 to 30.11.2021. Since the constitution of the STF 2018, more than 4000 unauthorised constructions have been demolished and more than 2500 properties have been sealed. Chairman, STF directed the ULBs to take the matter of pendency seriously and expedite the action on the pending cases.

Encroachment removal action was taken by SDMC at areas including Mehrauli bus terminal and ESI hospital, school road yogmaya mandir gate on 09.11.2021, Canara bank road, Munirka metro station, community centre Munirka, furniture market Munirka, Rama market on 12.11.2021, Begampur village near park, Shivalik road, near metro station in Pragati maidan, Lal kuan Pahlad Pur on 15.11.2021, furniture market Amar colony on 16.11.2021, Kishangarh, Mehrauli on 17.11.2021, central market, Veer Savarkar marg, Firoz gandhi marg, Lajpat nagar on 21.11.2021 and Vasant lok Vasant vihar, Priya cinema, PVR complex, Vasant Vihar, munirka marg near community toilet complex road, Vasant Vihar metro station, vasant vihar on 30.11.2021.

Encroachment removal action was taken by NDMC at areas including Shankar market, Janpath, Gole market, Sarojini nagar, Chankyapuri, AIIMS, Pijanji village, Rajiv chowk and Palika bazar.

77th MEETING

The 77th meeting of the STF was held on 17.12.2021 wherein officers from all the local bodies and other concerned agencies were present. The progress of the complaints received up to 15th December 2021 was reviewed.

In total 112264 complaints have been received in STF till 15th December 2021 and action on 107064 complaints has been initiated. 2261 ATR were received during the period from 01.12.2021 to 15.12.2021. Since the constitution of the STF 2018, more than 4050 unauthorised constructions have been demolished and more than 2550 properties have been sealed. Chairman, STF directed the ULBs to take the matter of pendency seriously and expedite the action on the pending cases.

Encroachment removal action was taken by SDMC at areas including Sultanpur Road Chattarpur on 01.12.2021, ChanderLok Cinema CR Park on 07.12.2021, Car Market Near D-2, Vasant Kunj, Church Road Vasant Kunj, Masoodpur, D-6 Vasant Kunj Road on 10.12.2021, Raja Ram Marg, BRT Road, DDA flat Madangir, Central Market Madangir, Block No. 10 Dakshin Puri, Maharshi Valmiki Marg on 15.12.2021.
