DDA TAKES VARIOUS MEASURES TO IMPROVE CONNECTIVITY IN NARELA

Narela Sub-city is one of the three Sub city projects and is situated in North-West of Delhi. The Sub-city is being developed to provide for the increasing housing requirement of people in Delhi and over 25,000 flats in various group housing pockets are constructed.

In order to boost the development and bring the connectivity of Narela Sub-city at par with other areas of Delhi, DDA is actively working with DMRC to bring metro connectivity to the far-flung areas of North-West Delhi. The Phase IV of Metro route for Rithala Bawana Narela has already been proposed by DMRC.

A series of meetings were held by DDA with DMRC and other stakeholders to finalize the metro route alignment for Rithala Bawana Narela to serve the already constructed housing pockets in Narela Sub-city Project and also to serve the Land Pooling areas.

DDA housing schemes of Narela Sub-city were less preferred in comparison to other areas of Delhi in the absence of a public Mass Rapid Transportation System. The proposed metro route would improve the accessibility and connectivity to the people of Narela. DDA has sanctioned funds for the implementation of metro in Narela and has released ₹130 Crores to DMRC for timely implementation of the proposed metro route.

DDA is also coordinating with NHAI & DMRC for integrated construction of metro and Urban Extension Road for cost efficient public means of transport.

This would result in the high pace of development of residential as well as commercial and institutional areas of Narela Sub-city and nearby areas. People shall have access and means to fast and economical transportation facilities resulting in better quality of life to the residents of Narela Sub-city.

DDA ADVISORY COUNCIL MEETS TO REVIEW MPD-2041

The DDA Advisory Council headed by Hon'ble Lt. Governor Shri Anil Baijal reviewed the draft MPD-2041 that incorporates the objections/suggestions from the public. Advisory Council consists of elected representatives from Rajya Sabha, Lok Sabha, Municipal Councillors, officers from Central Government, GNCTD and experts from the field of urban development/planning.

Most of the valuable suggestions earlier provided by me are already included in the plan and the remaining new suggestions were noted down and were suitably incorporated in the draft MPD-2041. In coming weeks, the draft MPD-2041 document will be placed before the DDA's Authority meeting under the Chairmanship of Hon'ble Lt. Governor of Delhi.

After approval from the Authority, Master Plan for Delhi-2041 will be forwarded to the Central govt. (MoHUA) for its approval and notification in the Gazette of India. The draft MPD-2041 document was approved by the Authority held under the Chairmanship of Hon'ble Lt. Governor of Delhi in its meeting held on 13th April 2021 and was published by the Authority in the Gazette of India on 09.06.2021 for inviting objections/suggestions on draft master plan. DDA had received approximately 33,000 (thirty-three thousand) objections/suggestions on the draft master plan during the period of 75 days.

Objections and suggestions received on draft MPD-2041 were placed before the Board of Enquiry and Hearing (BoEH) constituted under Vice Chairman, DDA for this purpose. Fourteen (14) nos. of meetings of the Board were held in the months of October & November 2021.

During the various meetings of BoEH, important urban/development related issues in the form of objections and suggestions were submitted by the general public, civil societies, NGOs, RWAs, market associations, federations, professional bodies and government agencies, political members etc.

Based on the objections/ suggestions certain modifications were suggested by BoEH in the draft MPD-2041. Master Plan for Delhi prepared by DDA under 'Delhi Development Act 1957' is a statutory document that facilitates Delhi's development by assessing the present condition and guiding how to achieve the desired development.

Implementation of the Master Plan is the collective responsibility of all agencies involved in the development of Delhi, including the Central Government, concerned departments of the Government of the NCT of Delhi, service providers, landowning agencies, regulators and local bodies among others. The first Master Plan for Delhi was promulgated in 1962 under the Delhi Development Act 1957, followed by the Master Plans of 2001 and 2021, each of which is an extensive modification of the respective previous plan document.

These plans were prepared for 20 years of perspective periods and provided a holistic framework for the planned development of Delhi. The Draft MPD-2041 is a 'strategic' and 'enabling' framework to guide the future growth of the city, built upon the lessons learnt from the implementation of the previous plans and based on learnings from across the country with respect to the implementation of various projects and schemes.

SUCCESSFUL DRAW OF DDA SPECIAL HOUSING SCHEME HELD

Delhi Development Authority successfully conducted a draw of DDA Special Housing Scheme 2021 on 18.04.2022. The draw of allotment of flats was done based on the 'Random Number Generation System' and held under the supervision of 3 independent observers headed by a retired Judge of High Court and Senior Officers of DDA. The draw was live-streamed for the general public through the link <http://dda.golivecast.in/>.

DDA initially placed 18335 flats located in 28 localities under the scheme. In response to it, only 12387 applicants have deposited the requisite registration fee, although 22, 100 (approx.) got themselves registered. The applicants were allowed to give a maximum of 7 preferences in terms of localities, but no preference in terms of block or floor. Out of the applicants paid registration money, preference for certain localities like Vasant Kunj, Jasola and Dwarka are overwhelming/adequate, but the preferences for Narela sub-city has not been as expected. Cumulative preferences of the applicants for LIG flats at Sector G7 and EWS flats at Sector A1 to A4, Narela have been 687 and 2234 respectively against the offered flats 6546 and 5033 in the above localities.

Therefore it was decided to put only 687 and 2346 flats of the above localities in the final draw so as to avoid the possibility of scattered allotment of flats to the applicants among various blocks/towers in these localities. Given the above facts, 9790 flats have been put in the final draw and 5227 flats have been allotted to successful applicants. A list of draw results is available on the DDA website dda.gov.in.

DDA TAKES A TRANSFORMATION LEAP TO DIGITAL

DDA started its journey in 1957 when it came into existence through an act of parliament has its own even on the lands and properties acquired and occupied by Govt. of India in the pre-independence and post-independence eras. After its inception, DDA has gone under various transformations in terms of the use of technology, and in the last two years, it has seen a complete facelift in the form of Digitalization.

With the vision to implement Hon. Prime Minister's vision of Ease of Doing Business and Ease of Living, DDA, in 2019-20 had taken up an ambitious e-governance plan to impart each and every service of DDA with a click of the mouse by the general public. A detailed framework was designed under the guidance of Hon. Lt Governor and a systematic approach was taken towards the Digitalization of DDA. Emphasis was laid on transforming manual processes into digital form. Citizen-centric services were earmarked wherein citizen was required to approach DDA to avail of the services. In order to facilitate the general public so that they need not make rounds of DDA offices to avail services, various workflows have been reengineered and online applications have been developed and operationalized.

Under the AWAAS project, all DDA housing schemes for allotment of flats have been made end-to-end online. Registration for the scheme, issuance of the Demand letter, receipt of payments, refunds and even possession letters are being issued online. For online receipts and payments, 12 banks are

providing online gateway facility to general public. Recently in DDA Housing Schemes 2020 total 33140 public users and for Special Housing Scheme 2021 total 22181 public users have interacted with our AWAAS application online for availing various online services.

Under BHOOMI project, entire process for allotment of land, E-auction, issuance of Demand letter, receipt of payments, refunds and possession letters are being issued online. System for offline payment and offline reconciliation of payments have been converted in e-form for speeding up the payment verification. The processes in these applications are end-to-end online, and applicant at any point of time can check the status of his case. During last two years itself more than 14000 persons have registered on our online E-auction portal for availing various online services.

The Interactive Disposal of Land Information (IDLI) System is being used very effectively by public for conversion of their plotted Residential, Commercial, Institutional, Industrial properties into freehold and their mutation etc. Similar application is operational for conversion of DDA Housing. Total 7200 properties have been converted online. Land Information Management System (LIMS) has been made operational for proper management of land records. It covers land records management, encroachment management and monitoring of demolition activities are major activities covered in it. Besides, all vacant land is being geo referenced and for this more than 4000 land parcels have been selected and are being geo-referenced.

A tie-up with ISRO has been done to take satellite imageries and other technical support from them time to time for monitoring of encroachments. Land pooling is yet another area where the digitalization has been done effectively.

The Land Pooling portal for registration of public is operational and various maps of land pooling area have been digitalized and uploaded on the portal. Servers have been taken from NIC for this purpose and very soon the land pooling application will be made operational end-to-end. 6922 landowners have registered online for expressing the interest in land pooling.

DDA has digitized 1500 Lay Out Plans covering planned areas of Delhi and have made them available on a GIS platform for use by general public. On this platform, attributes in respect every plot, its dimensions, land use etc can be verified. PM-UDAY is a flagship Scheme of the Government wherein the entire process and processing is in electronic / digital form since its inception.

Around 4 lakh applicants have registered on this portal and are availing PM-UDAY services in digital form. DDA has updated its website and has provided all citizen centric information to the public in a very user-friendly manner. The Appointments are provided online and public dealing is done through Video conferencing as well as physically. The Visitors in DDA are controlled and monitored through computerized Gate Passes. For interaction with public, State of Art interactive Computerized Call Centre is operational.

For redressal of public grievances a robust system of mobile applications and web enabled application has been established which is going to be integrated with other centralized systems of Govt of India like CPGRAM and LG Listening post. The grievance handling of STF (Special Task Force) for curbing encroachments on public land is also an added feature in the grievance redressal system.

In last two years 132049 cases of STF and 60187 cases of other Grievances have been addressed online. For Master Plan 2041, an online feedback system is operational, through which 33,000 persons from general public made their suggestions on the new Master Plan under formulation. Online services are also available for Sports facilities, Community hall booking, booking of parks and function sites, Registration of RWA, water bills and many such miscellaneous citizen services. Total 35573 online bookings have been done.

The human resource of any organization is considered the most precious asset. A set of NIC applications known as EHRMS (Employees Human Resource Management System) has been implemented for day to day affairs of employees right from their appointment till their retirement such as their leaves, payments, perks, medical, reimbursements etc. have been made online.

The personal records of employees in the form of Service Books have mostly been scanned and uploaded on this system. The data of more than 5000 employees of DDA is available on EHRMS application.

For effective management of court cases, online court case management system PROVAKIL is also implemented and about 20 thousand court cases are being monitored through it. For implementing the e-governance plan, state-of-the-art Computer Network have been established at all 10 major office establishments of DDA with dedicated lease lines for Internet and wi-fi resulting in fast inter office and online file movement and information movement and facilitating in quick disposal of public matters. E-OFFICE application of NIC has been implemented throughout DDA and file processing in DDA now is completely in electronic form.

As on date more than 15000 are live files and are processed on E-Office only. During COVID-19 crisis, this online file processing facility and video conferencing worked as a boon for DDA due to which all officials were able to work from home. More than 2000 inter deptt. and intra department meeting have been conducted online in last 2 years.

For ensuring the protection and security of public information related to lands and properties, the servers of National Informatics Centre have been taken in their data centre at Bhubaneswar. In DDA the Computerized record rooms have been established for systematic record management.

More than 02 lac files have been ported by various deptts on this system and placed in almirahs with proper system. The digitization of old records includes Scanning and digitization of more than 6 lacs files, 1500 Layout plans/Planning Maps, Revenue Maps of 240 villages and personal records of employees etc.

For bringing transparency in procurement, GEM and E-Tendering facilities are utilized extensively for procurement processes and no physical tendering is operational. Thus, DDA is galloping towards complete computerization with a vision of imparting all services to the public online so that no one will make the rounds of DDA offices for services. In last two years the work of automation has been done on war footing level and no area of DDA has been left untouched from computerization and the goal of complete computerization is not far away.
