paralysed son to death

New Delhi: A 30-year-old paralysed man died after getting beaten up with a stick by inebriated father northwest Delhi's Bharat Nagar on Sunday. The accused has been arrested.

Police got a call on Sunday at 1.24pm from a hospital that they had admitted one Paramjeet, a resident of Wazirpur, in an unconscious state. "Upon examination, the doctor declared him brought dead. The body was shifted to another hospital for autopsy," said an officer.

The deceased's Rekha, told police that on sister Sunday morning when she came to her home, Paramjeet was lying injured on the bed. "He told her that on Saturday night his father returped home drunk and beat him

up with a wooden stick," added the officer.

Paramjeet got paralysed after a road accident 14 years ago and was bedridden. On Sunday, his sister took him to the hospital, but he was declared brought dead.

On Rekha's statement, a case under IPC Section 302 (murder) was registered at Bharat Nagar police station. "We arrested the accused from his house in Wazirpur. Further investigation is on," said DCP (Northwest) Usha Rangnani.

The accused, an alcoholic, told investigators that his son's injuries were not serious. He was not able to give the exact reason for committing the crime. "In the past too, the father and son had got into arguments over household issues. The father, a labourer, was unemployed," the officer said.

Court raps man presenting himself as pauper to avoid paying maintenance to wife

New Delhi: A court has pulled up a man, allegedly presenting himself as a "pauper" to avoid paying monthly maintenance to his estranged wife, saying that he was the director of a company that has Indian cricket team captain Virat Kohli as its brand ambassador.

The court was hearing an appeal filed by the man against an order that directed him to pay Rs 30,000 monthly maintenance to his wife.

"This court can take judicial notice of the fact that the brand ambassador of the said brand is Virat Kohli, the Test cricket captain of Team India. Therefore, it looks highly improbable that a company, which is running into great losses (as claimed by the appellant), was in a position to afford a celebrity of such stature for advertisement of its products," said additional sessions judge Anuj Agrawal in the order on January 3.
