HON'BLE LT. GOVERNOR INAUGURATES



i. Utsav Sthal Pandal at Dakshinpuri

In line with the vision of Hon'ble Prime Minister to provide Ease of Living to all citizens of the country, Hon'ble Lt Governor Delhi Shri V K Saxena inaugurated DDA's Ustav Sthal Pandal at Dakshinpuri on 17.09.2023. On the occasion, Shri Ramesh Bidhuri, Member of Parliament South Delhi, Shri Subhasish Panda, Vice Chairman DDA and other dignitaries were also present.

Celebrating the 73rd birthday of Hon'ble Prime Minister, electric potter wheels were distributed to beneficiaries by Hon'ble Lt Governor and organ donation pledge were taken by all dignitaries and public present at the inauguration ceremony.

Hon'ble Lt Governor said utensils made of clay are environment friendly and need to be encouraged. He appreciates the hard work of the artisans in making extremely beautiful art work. He said 50 families are being handed over electric potters wheel and the government is identifying more beneficiaries.

On the occasion of birthday of Hon'ble Prime Minister, thousands of people gathered to take pledge to donate their organs and serve the society even after their death.

Besides, there is double storeyed utility block with hall and kitchen, separate public toilet block for ladies and gents, paved parking area of 4420 sqm, among others. This Utsav Sthal Pandal can host around 2000 people at a time.

The festive and marriage seasons are coming. Residents of Delhi, particularly people living around this locality, will have the opportunity to book the new community hall at an economically reasonable price, offering them a space convenient and suitable to organize their events and celebrations.

DDA has been working relentlessly for the overall development of Delhi. Last month, state-of-the-art DDA Sports Complex at Sector 17 Dwarka was inaugurated. Besides, 2 Foot over bridges and 1 Ustav Pandal were also dedicated to public in Dwarka.

Many major projects are in the pipeline and are expected to be completed by end of this year, including Centres of Excellence in many sports like wrestling, weight lifting, boxing, judo, kabaddi, tennis, shooting, football, hockey and a golf course is also coming up in Dwarka.



ii. Musical Fountain at Baansera

Hon'ble Lt. Governor Delhi, Shri Vinai Kumar Saxena, on 22.09.2023, inaugurated a musical fountain at Baansera - the one of its kind public amusement facility created on the banks of River Yamuna. The musical fountain has been installed in one of the three water bodies created at Baansera that would add to the aesthetics of the bamboo-themed park and provide the people of Delhi with a new leisure and amusement facility in the heart of the National Capital.

Delhi Chief Secretary, Shri Naresh Kumar and DDA Vice Chairman, Shri Subhasish Panda were also present on the occasion.

To begin with, two musical fountain shows - at 7:30 PM and 8:30 PM - will be held from Tuesday to Sunday every week on paying a nominal fee. Entry will be free for children up to 10 years and school-children accompanied by parents/teachers/guardians.





Speaking on the occasion, the Hon'ble LG said, "Delhi needs many such places for entertainment and leisure. Baansera is one of them developed by DDA and many projects are in pipeline."

The fountain, funded and set up by DMRC under its CSR Program, is equipped with digitally colour changing LED lights of grid size of 90 metres long, having multiple water effects & shapes with ultra-fast action jets. It has two modes - Auto Frequency Mode and Pre-Programmed Mode. The fountain has day time running water features which includes, 8 high column jets & one centre high jet going upto 30-50 feet. It will additionally provide aeration to the pond water during day time.

To enhance the ecological character of Yamuna floodplains and make it more people-friendly by making it attractive as a recreational and cultural venue, LG, Shri Saxena had laid the foundation of 'Baansera' in August 2022 and the same was



developed in a record time of just 6 months. More than 25,000 special variety of Bamboo saplings, brought from Assam were planted here. Baansera aims at providing the people of Delhi with the much-needed public spaces in the Capital on one hand, and also ensure that the rich biodiversity of the floodplain is preserved and maintained.

DDA's well-known Projects for Restoration and Rejuvenation of the floodplains of River Yamuna are being carried out as an initiative to enhance the ecological character of the floodplains and to make them accessible to the public at large. The Baansera Project, conceived and guided by the LG himself, will take such initiatives to the next level.

DDA RESUMES WALK-IN PUBLIC HEARING

CYCLE WALK PROJECT

The Cycle Walk project is envisioned as a Pro Ecology initiative as a part of the Climate Change Resilience effort of the Government to serve the twin purpose of strengthening the forest and Master Plan greens as well as creating a safe dedicated walking and cycling track for citizens to engage meaningfully with the beautiful city forests and Master Plan greens of Delhi.

The Leg A of the Cyclewalk project starting from Sangam Vihar to Malviya Nagar Metro Station, imagines planting of thousands of Indigenous trees and transplantation of a few trees within the forests. In Sangam Vihar area, there is hardly any vegetation on ground except some kikkar trees. In Delhi Cyclewalk project, the indigenous trees will be planted all along the Cyclewalk track. Approx. 8 acres of new forest land is also being added by the DDA to the city's forest cover and therefore the biomass and carbon sequestration capacity of the city shall get upgraded as a consequence of this project. The Indigenous trees being planted shall also have many fruiting trees like Gular and Pilkhan which offer a great habitat for birds to thrive. Approx. 4000 indigenous trees are being planted. Also, shrubs and



ground covers which attracts bees and butterflies are being introduced to strengthen the ecosystem.

Cycling tracks currently exist in Sanjay Van and no adverse effect on ecology has been observed over the years. Walking tracks exist within Jahapanah City Forest and no adverse effect on ecology has been noticed so far. The proposed cycle track has a Kutcha track for walking as well as a kutcha track for cycling, planned very carefully meandering through the trees in order to avoid damage to the trees. While proposing the Cyclewalk, the already existing redundant path along the boundary of Jahapanah forest has been thoughtfully designed. There will not be any tree cutting in lieu of the pathways and reduction of green cover. Otherwise, the Central Empowered Committee (CEC) would not have considered this proposal.

To avoid tree cutting for Cyclewalk, the track has been meandered and cross overs have been proposed over ditches and low-lying areas. Since earth filling has been avoided, the low-lying areas will act as water reservoir and natural water harvesting area.

There's absolutely no chance of a motorised vehicle operating on these tracks as they are kutcha tracks and quite narrow for vehicles as they meander. Also, each point of entry shall be guarded and has bollards with narrow gaps to disallow any motorists to enter.

The number of cyclists is to be regulated right at the gated entry plaza. In Jahapanah Forest, the number of cyclists / pedestrians has been restricted per day at a time using the proposed cycle track. No Night movement is to be allowed.

Forests ecosystem is being strengthened by connecting forests through land bridges so that the diversity is strengthened through better connectivity. Walkers and cyclists can also move from one forest / city forest / regional park to another seamlessly in a safe manner. Animals shall also have safe passages to move from one green space to another safely without the risk of being run over or crushed on roads and thereby developing a robust forest ecosystem.

The Project has been well planned and meticulously thought through and has been evaluated and approved through a due process of scrutiny and got approvals from:

1. The Department of Forests, wherein the officials have had a number of meetings off site and on site and thereafter over a number of deliberations, enhanced improved the ecological friendly aspects of the project.
2. The National Monument Authority as many monuments are in the vicinity of these tracks and the aspects of Heritage and contextual reverence incorporated into the entrance gate and grills design etc.
3. The Delhi Urban Arts Commission has evaluated and approved the project, which comprises of eminent architects and landscape architects.
4. The Ridge Management Board which has the mandate of regulating the ridge areas has evaluated the project and recommended it to the Central Empowered Committee.
5. The Central Empowered Committee has evaluated the project and done field visits and sent its recommendation to the Hon'ble Supreme Court of India.

Some of the design key features of the Cyclewalk are as under:

Watering holes with base of pebbles and sand to act as small water bodies as well as rain water disbursal pits.

In the pedestrian walkways, pervious materials like Moorum that allows water to easily percolate are to be used.

Swale drains along tracks are proposed for efficient ground water recharge.

Creating composting yards at every 1 Km for fallen leaves & wastes, and reusing it as manure. Providing Dustbins along the tracks with every 400m intervals.

Connecting People to Ecology is another feature in the proposal such as:

- i. Nomenclature and name of the tree with its benefit will help people to know about flora.
- ii. Signage board of fauna with write up detail about animals, help people know about the fauna of the forest.
- iii. Signage board of avifauna with write up detail about birds to help people know about the avifauna.

OBSERVANCE OF HINDI PAKHWADA AT DDA VIKAS SADAN




