DDA से नाखुश, गांवों की अनदेखी का आरोप

दिल्ली में मास्टर प्लान 2041 को लेकर डीडीए ने अपनी तैयारी पूरी कर ली है, लेकिन दिल्ली के ग्रामीण ग्राम विकास योजना बनाने की मांग कर रहे हैं। उनका आरोप है कि ग्राम विकास योजना की उनकी मांग पर डीडीए के साथ सहमति नहीं बन पा रही है। साथ ही उनका आरोप है कि मास्टर प्लान 2041 दिल्ली के शहरी इलाकों के लिए है न कि ग्रामीण इलाकों के लिए। क्योंकि गांव के लिए कोई नीति नहीं बनाई जा रही है। पुराने मास्टर प्लान में जो नीति बनाई गई थी, वह तक अभी पूरी नहीं हुई है। ऐसे में मास्टर प्लान 2041 से पहले ग्रामीण चाहते हैं कि वह गांव में ग्राम विकास योजना के तहत हर गांव की अपनी जरूरत के अनुसार योजनाएं तैयार करें। इसे लेकर कई गांवों के लोगों ने डीडीए, शहरी विकास मंत्रालय, एलजी विनय कुमार सक्सेना और आवास एवं शहरी विकास मंत्री हरदीप सिंह पुरी को पत्र भेजकर ग्राम विकास योजना पेश करने के लिए एक बैठक की अनुमति मांगी थी, लेकिन ग्रामीणों को यह अवसर नहीं मिल सका।

मुबारकपुर डबास गांव से चौगामा विकास समिति के महासचिव विजेंद्र सिंह ने बताया कि दिल्ली में अलग-अलग गांव की अलग-अलग समस्याएं हैं। मुबारकपुर डबास गांव को लेकर हम ने ग्राम विकास योजना की मांग करते हुए गांव में मूलभूत सुविधाओं को वहाल करने की मांग डीडीए से की थी। इसके साथ ही मास्टर प्लान 2041 में गांव के लिए बेहतर प्लानिंग की भी मांग की गई थी। जिसमें गांव के लोगों मास्टर प्लान 2041 में गांवों के लिए कोई नीति नहीं बनाने का लगाया आरोप

ITO barrage woes: 3 gates mired in silt, work underway with Navy diving team on standby after recent floods in capital

NEW DELHI, JULY 27

TWO WEEKS after the spotlight was thrown on it, three of the ITO barrage's gates have refused to budge, resisting persistent efforts to haul them up and out of the way of the river's floodwaters.

The Indian Navy's diving team remains on standby at Asita East, part of the Delhi Development Authority's (DDA) now-submerged floodplain project, near the barrage which is owned and supposed to be maintained by the Haryana government.

The team, with 24 personnel at one point along with equipment from Mumbai being brought in, is present round-the-clock in case a diving effort may be required again to free the gates from the silt they are mired in.

Captain Sanjay Kadian, who heads it, said they got a call on July 14 regarding five of the 32 gates of the barrage being shut, asking they be cut since they have the capability. By July 18, two gates were opened. "We tried lifting gate 31 with a crane, but that didn't work," he said.

The river's water level receded

Tuesday only to rise again Thursday – but silt remains, according to Navy officials.

This silt has been holding the gates to the ground – their winches not being able to lift because of suction from the ground. A gate has even resisted a 140-tonne crane – the biggest that could be deployed – operated from the road above, which attempted to lift it after cuts were made on its sides.

Two gates are closer to centre of the barrage and bear heavy water flow, making it tougher to be worked upon; a team has been deployed by the civil administration to manually excavate some of the silt at gate 31. The Delhi and Harvana governments are also involved in the exercise. Sources associated with efforts said an excavator or a dredger closer to the gates may work. An excavator was deployed Wednesday, when water levels were still low, but wet silt prevented it from moving closer to the gates.

Satbir Singh Kadian, Engineer in Chief, Irrigation and Water Resources Department, Haryana, said, "Pressurised water jets were initially used to clean the gates, but sediments remained. We have been told about dredging, we are

looking into these."

The Delhi and Haryana governments have recently sparred over the maintenance of the barrage. Sources in the Haryana government admitted the five gates had not been operated for five years adding that they had not anticipated that 27 open gates would prove insufficient to take the water discharge.

The money for maintenance was paid by the Indraprastha Power Generation Company Limited, which was decommissioned in 2018 and no money has been paid since.

"We should have been more cautious that the structure be maintained. We worked on the assumption that the design structure is for 10% redundancy (10% of the gates in the barrage are to be spare)," a source in the Haryana government said.

The Delhi government has sought the ownership of the barrage several times over the years, but Haryana insists on status quo as it wants to monitor the river levels downstream through its own mechanism.

"Why did the water level rise? In 2019, 8.5 lakh cusecs were released (from the Hathnikund barrage in Haryana, which determines levels downstream in Delhi), the passage was clear, there were no encroachments, and all the water passed," Kadian said.

According to Delhi government sources, the fact that the gates were shut came to the fore only "at the peak of the crisis" on July 13-14. say that even if all of the gates are opened, it will only help ease the situation only to about 5% to 7%," a Delhi government official added. To what extent was the barrage responsible for flooding? Ecologist C R Babu said, "The real cause is that we have reduced the flood carrying capacity of the floodplain—water used to spread horizontally over the floodplain

AAP, BJP bicker over slum rehab scheme

New Delhi: Aam Aadmi Party MLA Rajesh Gupta on Thursday alleged that a conspiracy was on under the Jahan Jhuggi Wahin Makan scheme of Delhi Development Authority (DDA) to harass the poor and leave them destitute.

Citing instances in the Wazirpur constituency, Gupta said that despite the DDA constructing flats and allocating them to many, the authority has arbitrarily disqualified several allottees through fraudulent and corrupt means.

"Despite sending multiple letters to the LG and DDA, no response has been received. To exacerbate the situation, community toilets that were used by the Jhuggi residents were demolished even before the flats were built on the pretext of creating a garden in its place so that they are forced to leave the place. The central government is demanding Rs 1,76,400 from eligible flat reci-

pients who are mostly dailywage labourers and cannot afford to pay," Gupta said.

DDA member and BJP MLA Vijender Gupta stated that the rehabilitation policy for the slum dwellers had been formulated by DUSIB, not the Centre. "The rehabilitation scheme is being implemented by the DUSIB so the chief minister is pretty aware of the terms and conditions. Even the rates charged from the slum dwellers are as per this policy. The AAP's statement shows their frustration as the Delhi government has failed to provide accommodation to the poor," he said.

The AAP MLA said: "We requested the DDA to offer loans to support poor people, but they turned a blind eye. Private companies saw an opportunity and sought to take advantage. People secure loans at an interest rate of 6-7%, but they were subjected to a staggering 12% interest rate. Why? Simply because they are poor."

DDA reclaims 229 acres since April

New Delhi: The Delhi Development Authority (DDA) has carried out 49 demolition programmes in the national capital since April this year and has reclaimed around 229 acres, the housing and urban affairs ministry told the Lok Sabha on Thursday.

It also said that no demolition has been carried out by the DDA, MCD and the Delhi Urban Shelter Improvement Board as a part of G-20 summit beautification drive in Kasturba Nagar, Tughlaqabad, Pragati Maidan, the Yamuna Flood Plains and Dhaula Kuan. "However, DUSIB, GNCTD has informed that occupants of night shelters in Yamuna flood plain have been shifted to other night shelters," the ministry said.

G20 preparations: Delhi L-G starts late-night inspections

NEW DELHI: Preparations for the G20 Summit meeting to be held here in September have picked up pace with agencies concerned running against time to spruce up 60 road stretches, Raj Niwas officials said on Thursday.

Lieutenant Governor V K Saxena has started late-night inspections of the ongoing work to ensure their timely completion, they said, adding it will continue till August 30.

AAP accuses Centre of expelling poor through flat allotment rigging

NEW DELHI: The Aam Aadmi Party (AAP) has launched a scathing attack on the Modi government, accusing it of orchestrating a scheme to force the poor out of Delhi by manipulating the flat allotment process under the 'Jahan Jhuggi-Wahan Makan' initiative.

Senior AAP leader and MLA Rajesh Gupta, has come forward with allegations of corruption and fraud in the Wazirpur constituency, where flats were built for slum-dwellers.

According to Gupta, the Delhi Development Authority (DDA) has disqualified several eligible allotters through fraudulent means, despite constructing and allocating flats to many residents. He further highlighted that community toilets, previously used by the jhuggi dwellers, were demolished even before the flats were constructed, leaving them without essential facilities.

The most concerning aspect

of the allegations is that the DDA is demanding a significant sum of Rs 1,76,400 from the eligible flat recipients. Gupta argued that the majority of these individuals, who work as daily wage labourers, could not afford such an amount and should not be burdened with it.

Appealing for assistance, the MLA said, "We requested DDA to provide loans to support these vulnerable people, but they turned a blind eye. Private companies seized the opportunity and offered loans at a staggering 12 per cent interest rate, taking advantage of their dire circumstances."

Furthermore, it was revealed that those without regular employment and the illiterate were denied loans, exacerbating the situation for the most vulnerable beneficiaries. Gupta also alleged that this was a deliberate move to demolish the Jhuggi settlements and replace them with large building complexes, ultimately driving the poor, illiterate, and elderly out of Delhi.

First meet: New Animal Welfare Board sets compassionate agenda

NEW DELHI: In a landmark initiative to protect and enhance the well-being of animals in Delhi, the newly-constituted Delhi Animal Welfare Board convened its first meeting on Thursday at Delhi Secretariat.

Chaired by Delhi Development minister Gopal Rai, the meeting brought together 27 passionate individuals, each representing various sectors and categories. The board will support organisations and bodies involved in animal welfare across the 11 districts of Delhi, providing financial and technical assistance, alongside valuable guidelines.

Addressing the media after the meeting, Rai emphasised that, "Delhi Animal Welfare Board has been constituted to work for the betterment of the animals in Delhi. A total of 27 members divided into 19 categories have been included in the Animal Welfare Board. This

One of the crucial decisions taken during the meeting was the allocation of five mobile veterinary vans, specially equipped to provide swift and efficient treatment to animals in distress across the city. These vans will be instrumental in reaching out to injured or sick animals, espe-

cially strays, and ensure they receive timely medical attention and care.

Additionally, the board has given instructions for the establishment of five state-of-the-art diagnostic centres, fully equipped with modern facilities for comprehensive health check-ups of animals. This will play a vital role in promoting early detection and intervention,

ultimately improving the overall health of animals in Delhi, Rai had announced.

The anatomy of the Yamuna floodplains

How has rampant construction blocked flood pathways and impeded the river's 'right to expand'? Why are Yamuna floodplains important? What are the consequences of rapid urbanisation on the floodplains? How many people are dependent on the river? What do encroachments do?

he story so far: Battered by heavy rains, the Yamuna looks slow, sluggish and swollen. Last week, the water levels hit a 60-year-high, gushing through elite neighbourhoods built close to the floodplains. Waters advanced towards the Taj Mahal for the first time in half a century. More than 25,500 people were evacuated and ferried to rescue camps in a brown stream of waste; many of them lived in make-shift low-lying slum dwellings next to the river.

Why is the Yamuna important? The late environmentalist Anupam Mishra once called Yamuna, Delhi's "real town planner": it meandered through Delhi ensuring the city was never short of water and never ravaged by famine or flood. Delhi was "well-planned along the course of the river Yamuna, but it isn't so anymore," he said. Causes, experts argue, can be traced to haphazard construction activities, rapid urbanisation, lack of proper housing and lax regulations – all of which have besieged the floodplains.

"We talk about rivers in isolation, but floodplains are inseparable from the river channel," says Venkatesh Dutta, a professor at the School of Earth and Environmental Sciences, Babasaheb Bhimrao Ambedkar University. The river system includes both water and land. Yamuna is a lifeline to five States, and its floodplains are a charging point.

Yamuna courses east of Delhi, entering the city from Palla village and exiting at the Okhla barrage. The floodplains are two km wide on each side. The floodplain along Yamuna's 22 km run in Delhi, designated as the O zone by the Delhi Development Authority, has an area of approximately 9,700 hectares - the size of 1,500 new Parliament buildings.

Between Palla and Okhla, the composition of the floodplains changes from farmlands to slums, colonies, Home and bridges. It is also dotted with permanent structures like Ring Road, Akshardham Temple complex, Commonwealth Games Village, Player's Building (housing the Delhi Secretariat) and the Indira Gandhi Indoor Stadium.

What is submerged now was once part of the river's natural flow, Dr. Dutta explains. A river has the "right to expand" and needs to breathe through its flood plains. Any attempt to concretise constricts its air supply. "This is happening not only in Delhi, but all major cities including Pune, Lucknow, Mumbai,"

As part of river systems, floodplains slow water runoff during floods, recharge groundwater and store excess water, replenishing the city's water supply. "When you have sluggish flow, the surplus water stored in the floodplain is released back during the non-monsoon season," Dr. Dutta explains. "If you lose the floodplain, you also lose the storage of water." Delhi recorded similarly devastating floods in 1978, 1988 and 1995 which inundated floodplains, adversely impacting their health.

Who lives on these floodplains? A 2022 report found there are 56 bastis (one basti has 15 or more houses), with 9.350 households and 46,750 people Almost half of the households (4,835) practise farming as a livelihood; others rely on daily wage work, fishing,

nurseries, and animal herding. Most residents migrated from Uttar

Pradesh, Bihar, Haryana, Jharkhand, West Bengal and Rajasthan; some bastis have existed for eight decades and others were built more recently. Farmers near Palla and Hiranki villages traditionally grow rice, wheat, and flowers on the rich silt

deposited by the river.

"Zone O supports a large variety of nature-based livelihoods with a low ecological footprint. Yet, these are being forcibly evicted in the name of ecological control of the region." the report rejuvenation of the region," the report noted. The farmland size has reduced from 4,850 hectares in 2000 to 3,330 hectares in 2020, as people were evicted, and livelihood shifted to daily wage work.

The National Green Tribunal (NGT) in 2016 imposed a blanket ban on agriculture-related activities till the Yamuna is restored and made pollution

On the NGT's orders, the DDA in 2021 evicted 800 families in the Muslim-dominated Batla House area, a part of the floodplains that falls under no-construction zones. Private contractors built flats and sold to people, mostly daily wage and domestic workers, who cannot afford housing in other areas.

How did settlements emerge?

The first major non-agriculture settlements appeared after Independence when refugees from Western Punjab fled to Delhi. They built kuccha houses on the floodplains along the Yamuna Pushta (from the ITO bridge and up to Salimgarh Fort). The planning era propelled urbanisation in the 1950s and '60s witnessing the construction of the first thermal power plant (employing people as labourers to unload coal from trains and clear fly ash), the Ring Road and Rajghat Samadhi

Over 180,000 jhuggis on the Yamuna Pushta were demolished during the 1975 Emergency, and people were resettled in the peripheries.

The 1982 Asian Games brought more than one million migrant labourers from neighbouring States, tasked with building flyovers, sports facilities and luxury apartments. Little to no formal housing was provided; workers eventually settled on the open plain along the western embankment after the Games. By 2004, almost 3,50,000 people lived along the Yamuna, according to estimates. They earned livelihoods as domestic help, rickshaw pullers, porters, mechanics, small vendors, factory workers in nearby trade markets such as Chandni Chowk and Sadar Bazaar. The population boom

outpaced Delhi's ability to build a proper sewage network and spiked Yamuna's pollution, Manu Bhatnagar of the Natural Heritage Division of Indian National Trust for Art and Cultural Heritage told *The Hindu* in an earlier interview.

The Delhi High Court in 2004 ordered eviction of "unauthorised" settlements on the floodplains, demolishing shanties and evicting more than two lakh people.
"Their subsequent eviction on the

charge of pollution cleared the way for the construction of capital-intensive projects of urban infrastructure and elite consumption," sociologist Amita Baviskar wrote in a paper. Large portions along the floodplains were used for projects – Delhi's largest depot for its public bus service, Akshardham Temple complex, Commonwealth Games Village, metro depots, luxury apartments, and highways. Moreover, Dr. Dutta says, "in the name

of flood protection," cities use embankments which "jacket the river, limiting the river's ability to spread."

What does Delhi's Master Plan outline?

The Yamuna floodplain was designated as a protected area free from construction in the Delhi Masterplan of 1962. The Central Ground Water Authority in 2000 also notified the floodplains as 'protected' for groundwater management. The draft Master Plan For Delhi 2041

divides Delhi into 18 zonal areas, designating Yamuna's floodplains as 'Zone O', delineated in two parts: river zone (active floodplain) and riverfront (regulated construction is allowed). The latter is where structures such as Akshardham Temple and Commonwealth Village have been built.

The South Asia Network on Dams, Rivers and People (SANDRP) in 2020 found large parts of the Yamuna floodplains and riverbed were "grossly abused" due to lax implementation: 23 bridges including rail, road, metro and barrages have been built; there was a bridge at every 800m. "The creation of new embankments, guide bunds... are fragmenting the floodplain, promoting encroachments, and also leaving a trail of construction and demolition debris into riverbed and floodplains," the group

An Expert Committee in 2012 formed to examine DDA's Riverfront Development Scheme warned against any construction on floodplains. The areas proposed under the Yamuna Riverfront Development (YRDF) plan - which proposes

biodiversity parks and 'recreational' activities - were within the active floodplain, which could affect the topography, increase pollution and affect flood-carrying capacity, the Committee

"If you build on areas reserved for recharge, you lose groundwater," says Dr. Dutta. The layers of sediments of floodplains create aquifers contributing to the river channel, which in turn rejuvenates the groundwater. But encroachments stop this two-way

warned.

The river is unable to transport flood waters downstream during monsoons, wet the lands or deposit soil along its banks to preserve the riverine ecosystem.

What do encroachments do? Floodplains also protect against devastating flash floods by allowing excess water to spread out and storing that

However, encroachments restrict the river to a small channel. Any intense rainfall activity (India received 26% more rainfall in July than expected) swells the river, expanding in height not in width, eventually spilling over with devastating intensity. Climate change has intensified rains in frequency and severity, and seen in the Yamuna floods, runoff water comes as a huge gushing flow in a small span of

Dr. Dutta notes that "floods are inseparable from the hydrological cycle and are required for sediment transport, cleaning the riverbed, rejuvenating the

The concept of floodplain zoning is not mainstreamed in the Master Plan," he adds, and authorities haven't yet "taken cognisance of the river's right to expand." cognisance of the river's right to expand."
This gap, along with poorly implemented policies, frees up river land for private and public real estate. "The common property land – the river's land – is open to auction and revenue generation. It's a tragedy of commons because the river's land has not been necessite defined." land has not been properly defined." A model draft Bill for defining

floodplains and zoning was circulated in 1975. Only four States have drafted a National Floodplains Zoning Policy so far.

It is "reductive" to locate floodplains as site of conflict between development and nature, says Dr. Dutta. Instead, action can be focused on creating climate-resilient infrastructures, de-silting drains, creating green areas and improving drainage systems, "You cannot police a river," he says.
