## DDA Authority Meeting

Delhi Development Authority held its meeting on 12.01.2021 through video conferencing under the chairmanship of Shri. Anil Baijal, Hon'ble Lt. Governor, Delhi/Chairman, DDA attended by Shri. Anurag Jain, IAS, Vice Chairman, DDA and other members of the Authority including Shri. Vijender Gupta and Shri. O. P. Sharma.

### Following major decisions were taken:

The Authority has approved the following proposals for consideration and final notification by MoHUA:

**TOD policy:** The policy for Transit Oriented Development (TOD) in Delhi was proposed along the influence zone of metro corridors and its provisions were incorporated in the various chapters of MPD-2021 notified by MoHUA in 2015. However, considering the carrying capacity of Delhi in terms of infrastructure requirement, the TOD Policy for Delhi was revised and notified by the ministry again in December 2019 in which mixed-use development was allowed only at the identified selective nodes of metro/ railway stations after assessing the impact of development on traffic & infrastructure requirements.

This revised TOD policy was incorporated as a separate chapter in MPD-2021. However, it required certain rectifications in the corresponding chapters to enable the revised TOD policy to be implemented on ground. In this regard, DDA had invited objections/ suggestions from the general public with respect to the proposed modifications in February 2020. After considering the objections & suggestions from the general public, the proposed modifications in MPD-2021 was approved. In the Authority meeting held on 23.12.2020, TOD Regulations were approved. After final notification, it will pave way for implementation of the revised TOD policy.

**Ravidas Gurughar (temple):** Hon'ble Supreme Court ordered to allot 400 sqm of land for the construction of Ravidas Gurughar (temple). Government of India formed a 11-member committee of devotees for the construction of the temple. As the land was located in Jahapanah City Forest, the change of land use from Recreational to Public and Semi - Public and NOC from forest department, GNCTD was required.

The Authority had initially approved the proposal for change of Land use in its meeting held on 09.10.2020 and invited public objections and suggestions. On the recommendations of Board of Enquiry, the Authority has approved and the proposal shall be sent to MoHUA of the final notification.

**Additional FAR and use conversion:** The additional FAR and use conversion for residential, mixed use, cooperative group housing societies (CGHS), and commercial properties were rationalised and notified in June 2018. However, the policy could not be implemented due to procedural aspects. Therefore, extension of time for applicability of existing rates had been given periodically. Due to the impact of COVID - 19 pandemic on economy, the existing rates are being retained for a further period of six months i.e. up to 30.06.2021 to provide relief to the lessees/owners of these properties. The Authority appealed to the people to apply expeditiously as this is the last opportunity to avail the benefit under the existing rates.

**Warehousing:** Giving fillip to logistics industry, 'warehousing' has been included in wholesale trade with increased FAR from 80% to 100% and ground coverage from 30% to 40% by amending the MPD-2021. With changing time and introduction of numerous online shopping sites, the demand for 'warehouse to home' model of business has increased the need of warehouses for various commodities. The approved proposal shall ease out the policy for warehousing.

**ILBS Hospital:** For expansion of essential facilities at Institute of Liver and Biliary Science (ILBS) Hospital, Vasant Kunj - New Delhi, the change of land use from Residential to Public and Semi Public for about 5.76 acres land was approved.

The Authority has given preliminary approval for the following case for inviting public objections/ suggestions under Sec 11A of DD Act:

**Sewage Treatment Plant:** To facilitate construction of decentralised Sewage Treatment Plants incorporating new technologies so that untreated sewage is prevented from going directly into the drains, the proposal to incorporate provision of Sewage treatment plant, which will include sewage pumping station and effluent pumping station has been approved.

It will promote zero waste facilities. A committee was formed comprising chief engineers of DDA, Delhi Jal Board alongwith DDA's Planning Department, which recommended for decentralised Sewage Treatment Plants based on the report prepared by professors of Indian Institute of technology.

**CNG in Community Centres:** Besides these, the Authority gave approval for facilitating CNG/EV fuel stations in Community Centres located on roads having RoW 24 metres as against the existing provision of minimum 30 metres to promote green fuel. This will facilitate siting CNG cum Electric Vehicle stations in the developed areas where there is no scope of road widening. CNG cum EV fuel stations are completely green fuel retail outlets which are the priority for Environment and are need of the hour.

## 60<sup>th</sup> Special Task Force meeting

The 60<sup>th</sup> meeting of STF was held on 15.01.2021 wherein officers from all the local bodies and other concerned agencies were present. The progress of the complaints received up to 31<sup>th</sup> December was reviewed.

In total 71,005 complaints have been received in STF till 31<sup>st</sup> December 2020 and action on 65,243 complaints has been initiated. 1643 ATR were received during the period from 16.12.2020 to 31.12.2020. Since the constitution of STF in 2018, more than 3100 unauthorised constructions have been demolished and more than 2100 properties have been sealed. Other kind of actions have also been taken up with concerned agencies such as DJB, Electricity, Revenue which comes to more than 2700. In addition to this, more than 7500 active actions have been taken up by the ULBs on unauthorised constructions.

Chairman, STF directed the ULBs to expedite the action on the pending cases.

During 16.12.2020 to 31.12.2020, demolition action was taken by SDMC in kh.235, Batla house, Ambedkar Colony, Chattarpur and Chattarpur Pahadi. Encroachment Removal Action was taken by SDMC at areas including Car market, RK Puram, Aurobindo Place market, Aruna Asif Ali road, Vasant Kunj, Savitri Nagar, Jamroodpur Commercial complex and Andheriamor.

Anti-Encroachment drive was carried out by NDMC in Janpath road, Parliament street, KG Marg, Firozshah road, Barakhamba road, Atul Grover road, Tolstoy Marg and Jantar Mantar road.

Anti-encroachment drive was carried out by EDMC in Krishna Nagar to Geeta Colony Block 1 Road and jheel Chowk, Dilshad Garden, Vivek Vihar to Jhilmil Road, Kailash Nagar Main Road to Chacha Nehru Hospital, Geeta Colony to Gopal Park, East Azad Nagar to Bholonath Nagar, Vikash marg to Chand Mohalla, Kanti Nagar Main Road and Main Road, Pilli Mitti, Road no.70.

DDA carried out removal of encroachment in the form of Dhobi Ghat at Batla House on 24.12.2020 on reclaiming approx. 1-acre land.

Revenue Deptt carried out removal of encroachment from Forest land at village Asola reclaiming 74 bighas of land.

Chairman, STF reiterated that close co-ordinated efforts need to be continued by the ULBs & Govt. Agencies to take actions for removal of encroachment in accordance with the law. Police Deptt. assured that all support shall be provided to remove the encroachment from roads and take action on unauthorized construction effectively.

## 61<sup>th</sup> Special Task Force meeting

The 61<sup>st</sup> meeting of STF was held on 29.01.2021 wherein officers from all the local bodies and other concerned agencies were present. The progress of the complaints received up to 15<sup>th</sup> January was reviewed.

In total 72,507 complaints have been received in STF till 15<sup>th</sup> January 2021 and action on 66,497 complaints has been initiated. 1254 ATR were received during the period from 01.01.2021 to 15.01.2021. Since the constitution of STF in 2018, more than 3200 unauthorised constructions have been demolished and more than 2200 properties have been sealed. Other kind of actions have also been taken up with concerned agencies such as DJB, Electricity, Revenue which comes to more than 2750. In addition to this, more than 7500 active actions have been taken up by the ULBs on unauthorised constructions.

Chairman, STF directed the ULBs to take the matter seriously and expedite the action on the pending cases.

During 01.01.2020 to 15.01.2020, Joint Encroachment Removal Action was taken by Revenue and SDMC in areas of Lado Sarai Old MB road (04.01.2021).

Encroachment Removal Action taken by SDMC at A Block DDA Market, Vasant Vihar Coolie camp, Munirka Marg (05.01.2021), Bhikaji Cama Place, Muhammadpur village (11.01.2021).

Anti-Encroachment drive was carried out by NDMC in areas including Shanker market, Regal, Bengali Market, Janpath, BKS Marg, Shivaji stadium, Rajiv Chowk, Indira Chowk and Palika Bazar.

Chairman, STF re-iterated that close co-ordinated efforts needs to be continued by the ULBs & Govt. Agencies to take actions for removal of encroachment in accordance with the law. Police Deptt. assured that all support shall be provided to remove the encroachment from roads and take action on unauthorized construction effectively.
