### 1. Eligibility: -

1.1. Only those bidders are eligible for uploading their Tender who have necessarily completed similar nature works under Central Govt./Central Autonomous Body /Central PSU's/State Govt./State PSU'S, Municipal Bodies with the condition mentioned below for the above-mentioned work provided they satisfy the following criteria: -

The firms/agencies/contractors who have successfully completed similar nature of works during last seven years ending previous day of last date of submission of application. The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of receipt of applications of tenders.

a) Three completed similar nature of works, each of value not less than 40% of the estimated cost put to tender

or

b) Two completed works of similar nature, each of value not less than 60% of the estimated cost put to tender

c) One completed work of similar nature of value not less than 80% of the estimated cost put to tender

Similar work means "Providing, installation, testing and commissioning and drawing & drafting of emergency fire evacuation plan & escape route marking."

Note: -

- 1.2. The tenders are invited from specialized/approved and eligible contractors of DDA in the appropriate class and other specialized eligible contractors. - 6. Tenderer must ensure giving complete information wherever required before submission of tender. In case, any deficiency noticed after opening of tender then no opportunity will be provided to tenderer to make good the same and the firm/contractor shall be considered ineligible. iv) The bidder will use one UTR for one work only. In case it is found that he has used one UTR number for different tenders, all the tenders submitted by him will be rejected and he will be debarred from further tendering in DDA in future.

- v) The Tenderer should furnish Rs. 50,938/- as Earnest Money in the form of RTGS/NEFT. The Earnest Money will be returned to unsuccessful bidder. Earnest Money of successful Bidder will be returned only after receiving the performance Guarantee; however, no interest shall be payable on the earnest money.
- 9. The eligibility documents shall be opened first on due date and time as mentioned above. The time and date of opening of financial bid of contractors found eligible shall be communicated to them at a later date.
- 10. The Financial bid of tenderers who satisfied eligibility criteria shall then be opened on a specific time and date which will be intimated separately.
- 11. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many tenders are received satisfying the laid down criterion
- 12. The quoted percentage rate by bidders will be considered up to two digits after decimal point.
- 13. Online tender documents submitted by intending bidders shall be opened only for those bidders, whose Earnest Money Deposited, proof of e-registration fee paid and other documents will be found in order. #### Care in submission of Tenders: -

- i) Before submitting a tender, the tenderer will be deemed to have satisfied himself by actual inspection of the site and locality of the works, that all conditions liable to be encountered during the execution of the works are taken into account and that the percentage rate be entered in the tender forms are adequate and all-inclusive to accord with the all the provisions of the standard / general conditions / clauses of contract / bid document for the completion of works to the entire satisfaction of the Engineer.
- ii) Tenderer will examine the various provisions of the central Goods and Services Tax Act, 2017(GST)/Integrated Goods and Services Tax Act, 2017(GST)/Union Territory Goods and Services Tax Act, 2017(IGST)/Union Territory Goods and Services Tax Act, 2017(UTGST)/respective state"s state Goods and Services Tax Act(SGST) also, as notified by Central/State Govt. & as amended from time to time and applicable taxes before bidding. Tenderers will ensure that full benefit of input Tax Credit (ITC) likely to be availed by them is duly considered while quoting rate.
- iii) The successful tenderer who is liable to be registered under CGST/IGST/UTGST/SGST Act shall submit GSTIN along with other details required under CGST/IGST/UTGST/SGST Act to DDA immediately after the award of contract, without which no payment shall be released to the contractor. The contractor shall be responsible for deposition of applicable GST to the concerned authority.
- iv) Every tenderer/bidder is required to be registered compulsorily himself under CGST/IGST/UTGST/SGST Act.
- v) TDS under the provision GST law shall be deducted from the bills and /or payment of advances as and when made applicable under the Act. Provisions of GST Act 2017 shall have the superseding effect over the all earlier taxes like VAT/WCT/Service Tax/other like taxes etc. as contemplated in the Act.
- vi) Accordingly, the terms VAT/WCT/Service Tax/ etc. appearing anywhere in the bid document may be read as the applicable tax under the GST Act-2017.
