- 2. The intending tenderer should ensure before tendering in DDA that the requisite fee has already been deposited with CRB.
- 3. Earnest money shall be deposited through RTGS/ NEFT in the account Sr. Accounts Officer CAU (Horticulture) account no.01201110000010 with branch of HDFC, GF 01, 02, 03, Laxmi Deep Building, Laxmi Nagar Distt. Centre Vikas Marg, Delhi-90 and IFSC code HDFC0000120. The unique transaction reference of RTGS/NEFT shall have to be uploaded by the bidder in the e-tendering system by the prescribed date. The Dy. Director (Hort.) concerned will get earnest money verified from CAU based on the unique transition reference number against each RTGS/NEFT payment before the tenders are opened.

<u>IMPORTANT TERMS & CONDITIONS FOR TENDERERS</u>. Tenderers are required to go through the same before participating in the tender.

- 1. The unique transaction reference on RTGS against EMD, shall be placed online at specified location for tender for Electronic Time and Attendance Recording System. The tender shall be submitted online in two parts, viz., technical bid and price bid. First cover containing "Technical Bid" as well as "reference of EMD, tender fee" and other specified documents and second one containing "Price Bid" (Financial Bid).
- 2. The technical Bids shall be opened online in the presence of a committee or their representatives by authorized bid openers. Price Bids of only those tenderers shall be opened whose technical bids qualify, at a time and place of which notice will be given. The Tenderer technically qualified will be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt or they can view the bid opening event online at their remote end.
- 3. The tenderer should furnish the Earnest Money in the form of RTGS. The amount will be retained by DDA as part of security deposit, in case tender is accepted, otherwise it will be refunded. However, no interest shall be payable on the earnest money.
- 4. The tender shall be submitted online in two parts, viz. Technical Bid and Price Bid.
- Eligibility Criteria:- Office Order issued by CRB, DDA vide Order dated 30.12.2022 shall be followed wherein works costing tenders upto Rs. 1.30 crore shall be issued to the contractors registered with DDA only.
- For works costing above Rs. 1.30 Crore up to 4 Crores, tender shall be issued to DDA & CPWD enlisted contractors as per their enlistment. The tenders shall also be issued to non-DDA, non-CPWD contractors provided they satisfactorily completed three similar nature of works, each of value not less than 40% of the estimated cost in the year last five years.

For works costing above Rs. 4 crores but upto Rs. 50 crores, the tender shall be issued to DDA contractors as per their enlistment. The tender shall also be issued to non-DDA contractors provided they have satisfactorily completed three similar nature of works, each of value not less than 40% of the estimate cost of two similar nature of works, each of value not less than 60% of the estimated cost or one similar nature of work value not less than 80% of the estimated cost in the last 7 years ending last day of month previous to the one which the tenders are invited. Note- Class-II contractors of DDA & CPWD shall also be eligible if they satisfy the above criteria.

The value of executed work shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum to be calculated from date of completion of work to last date of received of application for the tenders. Similar nature means "Maintenance of Toilet / Bio Toilet work"

Turnover: -

The agency should have annual turnover of more than 50% of the estimate cost during the immediate last three consecutive financial years ended on 31st March, 2023 duly certified by the charted accountant.

Profit /loss: -

The agency should not have incurred any loss in more than two years during the last five years ending 31st. March, 2023.

Solvency Certificate: -

The agency should submit solvency certificate from scheduled bank for an amount 40% of the estimate cost which should not be more than six months old from the date of submission of tenders.

The EMD declaration form shall be placed online on the website.

Bidder/tenderer registered in Contractor's Registration Board (CRB) of DDA are required to pay the e-tendering annual charges as under:
